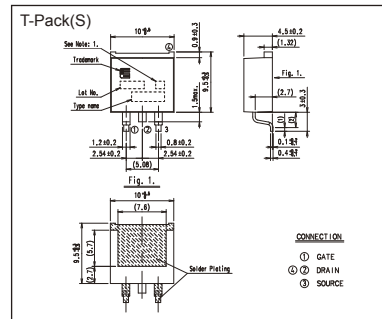
■ Features

- High avalanche durability

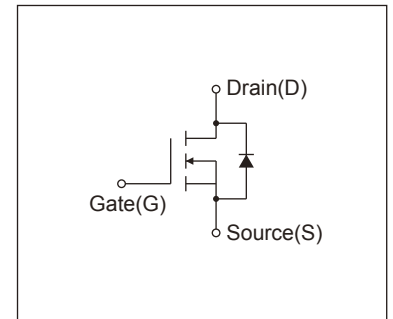

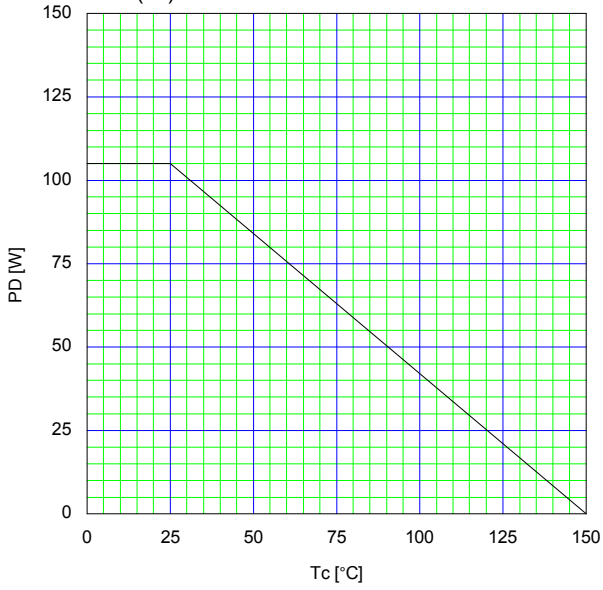

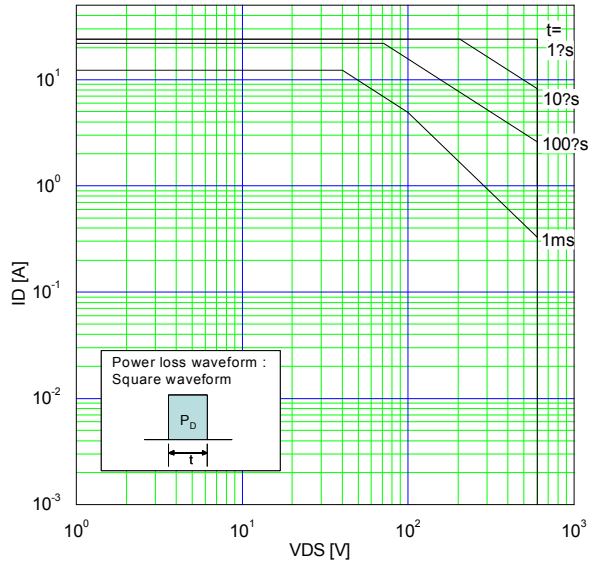

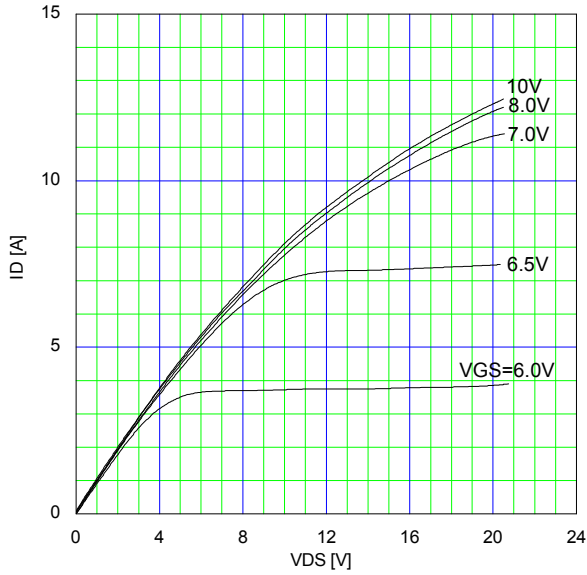
Allowable Power Dissipation

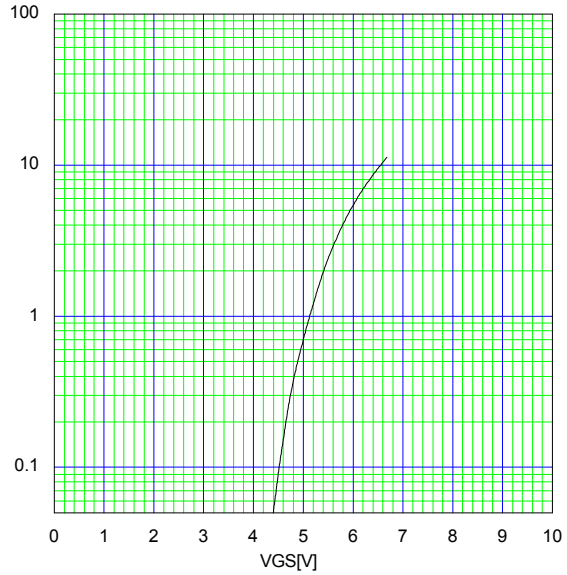
Safe Operating Area

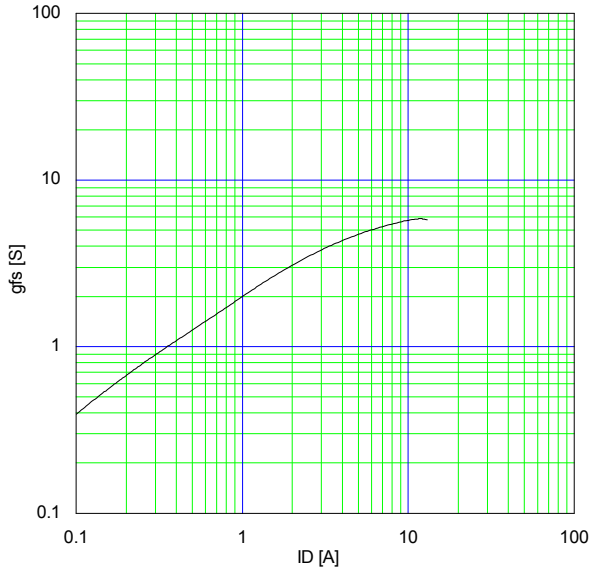
Typical Output Characteristics

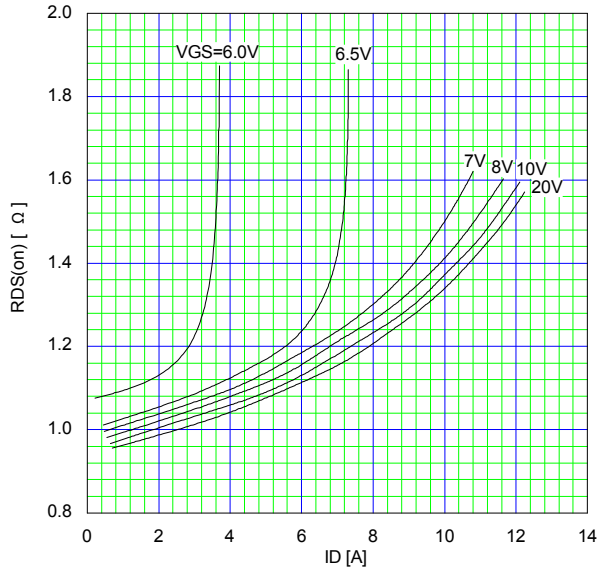
Typical Transfer Characteristic

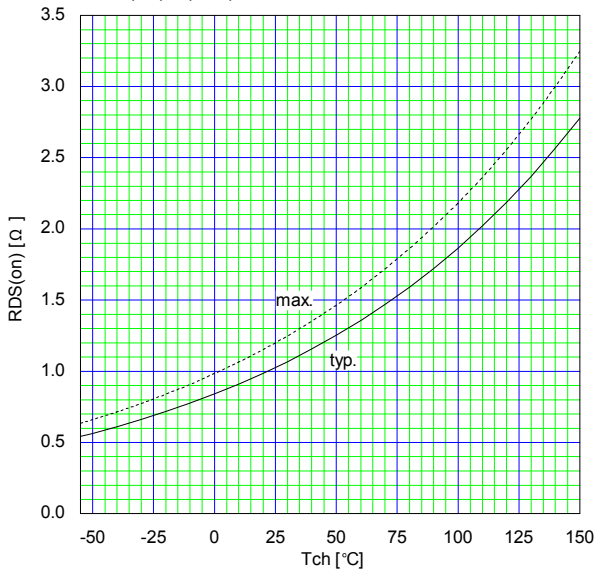
Typical Transconductance
 $g_{fs} = f(I_D)$: 80 μs pulse test, VDS=25V, Tch=25 °C



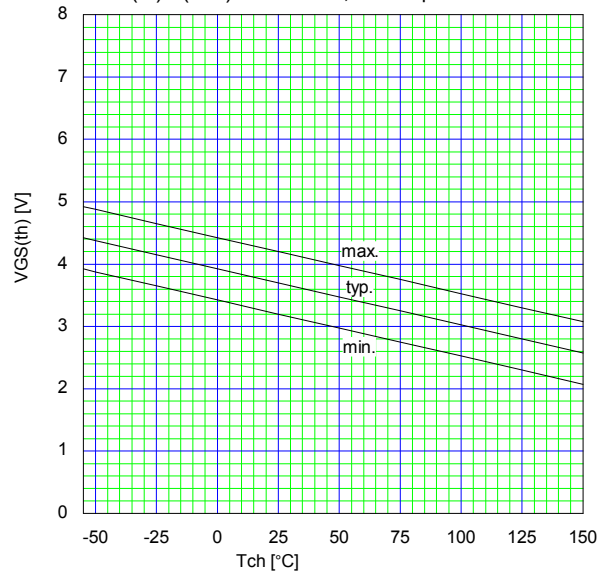
Typical Drain-Source on-state Resistance

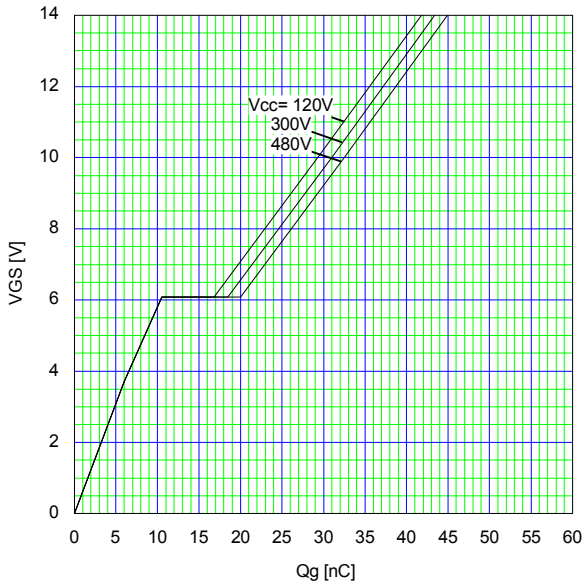
Drain-Source On-state Resistance

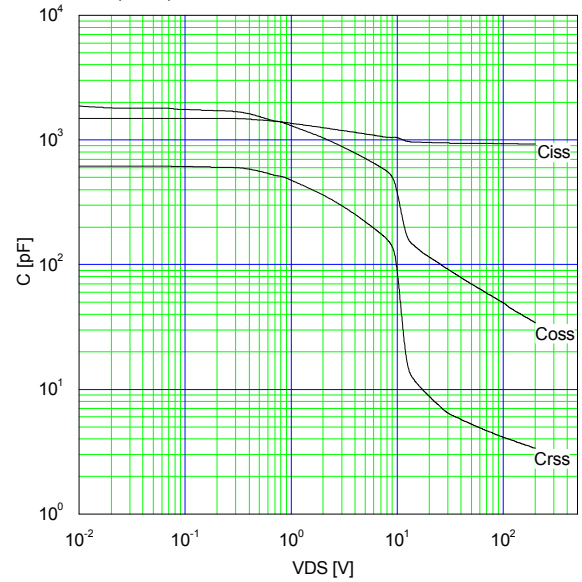
Gate Threshold Voltage vs. T_{ch}

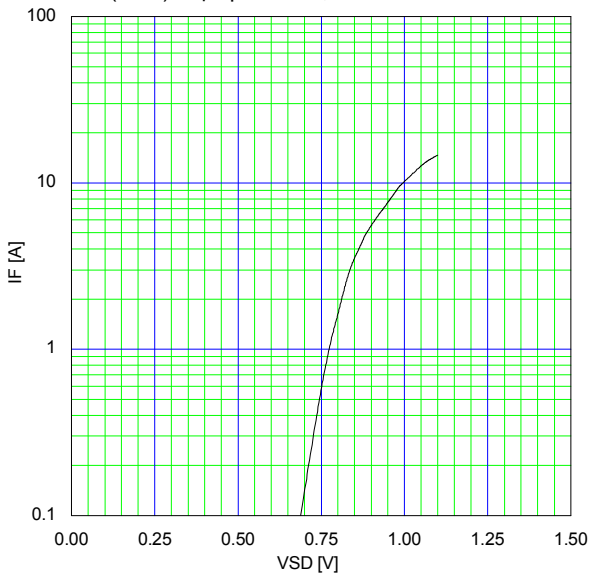
Typical Gate Charge Characteristics

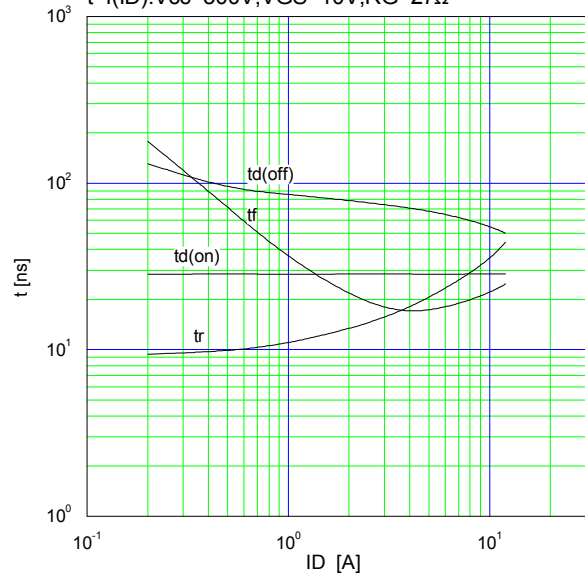
Typical Capacitance

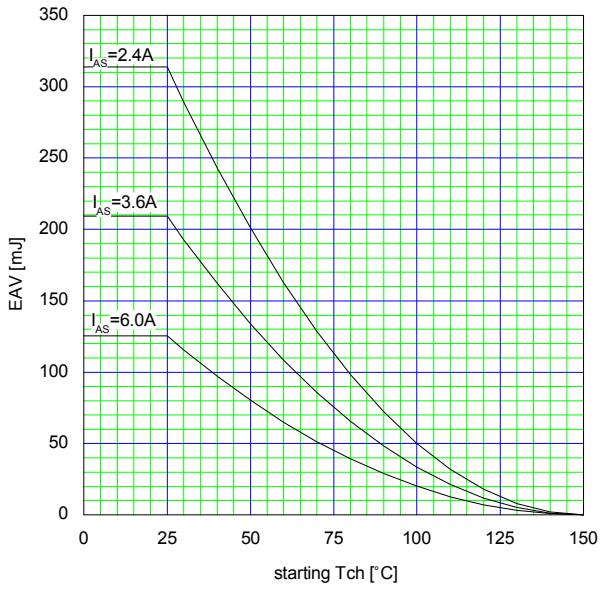
Typical Forward Characteristics of Reverse Diode

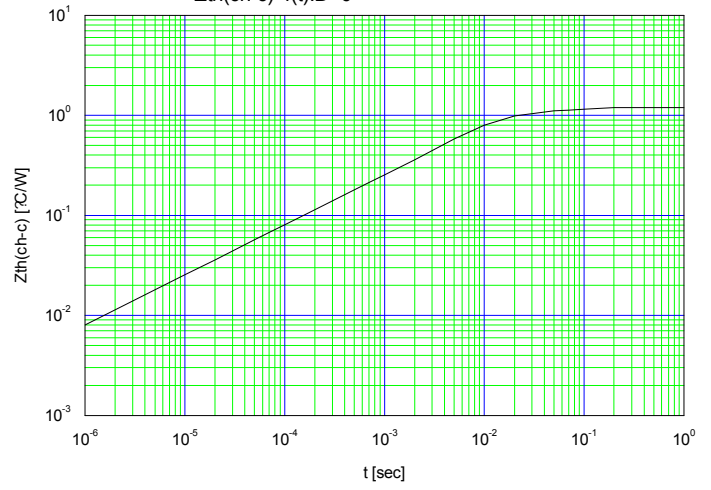
Typical Switching Characteristics vs. I_D
